1. Programme Name – She Arise 2020-21

2. **Cost** - Complete Training is Free of Cost to all the students.

3. Duration of the Programme –

- Total Duration: 350 Hrs
- Instruction Mode Online Training: 250 Hrs (Technical + Cognitive skills)
- Self-Learning Modules through LMS: 100 Hrs

4. **Eligibility Criteria for Beneficiaries** – Passout girls of 2017-18, 2018-19 B.Tech CS, IT & MCA Branch who are not employed as of date/lost their jobs during Pandemic/Taken Sabbatical from their work.

Students would appear in online classes through Laptop and Stable WIFI Connection only. Laptop must have a working Webcam and Mic.

5. **Mode of Training** - Online instructor mode

6. **Attendance** – 85% Attendance is Mandatory to be the part of the Training (Also the students that would be absent in the class continuously for 3 days without any prior notice can be removed from the training)

7. **Placement** - Placement assistance to be provided to all the beneficiaries from NASSCOM Foundation as well as from Centum Foundation.

8. **Certificates – Industry Aligned Certification.**

9. **Assessments** – To analyze the performance of candidates, weekly Assessment and Assignment would be the mandate part. Additional to this, students' performance would be Analyzed and monitored through 3 Major Assessments (1st one is baseline Assessment, 2nd is Midline Assessment & the final assessment)

10. **Batch Enrollment Process** – Once enrolled, the students will go through a Psychometric test. Students would be enrolled into different courses basis their aptitude and domain knowledge.

12. **Student Declaration** - Students must provide a Disclaimer that they will attend complete Training and Assessments and will opt for a job, before the training starts
